Risk Assessment: Pastoral Visiting

This risk assessment has been drawn up in order to protect the needs of the individual: both the adult being visited, and the member of clergy doing the visit. In this way, both individuals know what is expected of them, and every visit can be carried out safely, bearing in mind both the needs of the individual and their safety.

Risks are identified and scored from 1 (being the least harmful) to 5 (being the most harmful). Where a risk is identified as being greater than 3, additional measures must be put in place to protect both the individual and the member of the clergy.

Spaces have been left on the form for you to fill in notes, and add any extra identified risk factors which are pertinent to the individual.

	Is there likely to be someone else present during the visit who could pose additional risk?			
	Does anyone who lives in the house, or anyone who is likely to come to the house, have a history of violence towards the family or towards professionals? Are they able to leave their home?			
	Can the home be evacuated quickly?

Past factors	Have there been any bouts of unacceptable behaviour shown in the past? Have there been any Safeguarding issues regarding this individual?			If any risks in this category score higher than 3, a Care Agreement is needed and additional records kept

Will they be visited at home or in a public space?		If this is a public space, how will the minister balance keeping themselves safe with a need for privacy for the individual?

Considerations	Notes	Precautions
Will the minister be on their own when visiting?		Does the minister have a way of contacting someone else if an emergency or dangerous situation arises?
How frequent will the visits be?		These should be monthly unless there is a greater need to justify more frequent visits. Be mindful of dependency.
Is a Pastoral Care agreement needed?		
Will records be kept?		Be mindful of the privacy of the individual, but explain that information may need to be shared with other services should the need arise.
